# THE INVENTORY OF EVALUATED HISTORIC RESOURCES

The Inventory of Evaluated Historic Resources is a database that lists historic resources in Calgary. It is maintained by Heritage Calgary on behalf of the City of Calgary.

MHR DESIGNATION -

The Inventory includes only those historic resources that have been fully evaluated by Heritage Calgary – not every "aged" property has enough integrity to be considered a historic resource.

Evaluations are based on a rigorous framework and a set of predetermined criteria approved by City Council. We issue contracts to independent researchers who conduct the evaluations and provide expert research and analysis of historic properties.

To be listed on the Inventory a resource must be at least 25 years old and meet one or more of the following values:

- 1. Activity
- 2. Event
- 3. Institution
- 4. Person/people
- 5. Style
- 6. Design
- 7. Construction
- 8. Landmark
- 9. Symbolic

Our Inventory is the cornerstone of Heritage Calgary's mission to identify, preserve, and promote. We work hard to maintain a comprehensive database that lists historic resources in Calgary, with extensive and individualized research identifying each resource's significance.

The evaluation and recommendation of historic resources for placement on the Inventory is performed by Heritage Calgary's Evaluation and Review Committee. Heritage Calgary evaluates and adds heritage resources to the Inventory based on expert research, analysis, and City staff input. Potential sites are brought forward by the community and then evaluated.

Evaluations are based on a rigorous framework and a set of predetermined criteria approved by City Council. In 2019, we added 23 sites.



#### APPROVE

The Planning & Development Committee reviews the bylaw and approves the granting of MHR designation The designation is then advanced to city council for final approval. Once council approves the MHR designation, the building is officially considered a Municipal Historic Resource.

### OWNER-LED DRAFT

The owner of an Inventory resource decides they would like their building to be formally designated as a Municipal Historic Resource (MHR).

**INTEREST** 

The City of Calgary heritage planning team works with the owner to draft a bylaw that will be registered on the title of the property. Bylaws restrict demolition and identify key elements of a building that have heritage value - only these items will be regulated once the building is designated.

## **OUR PROGRAMS**

#### **HISTORIAN-IN-RESIDENCE**

The Historian in Residence program is a sixmonth community engagement residency that supports historians and researchers working in any genre related to Calgary's (Moh'kins'tsis') social, cultural and built history.

The 2021 Historian in Residence is C.W. (Cory) Gross. Cory is a professional educator with over 20 years of experience in museums and heritage. His primary field is the geology of Western Canada and its intersection with Indigenous, settler, and immigrant histories. In early 2020 he published his first book, The Ice Age in Western Canada.

The Historian in Residence is presented in partnership with the Calgary Public Library.



#### **WALKING TOURS**

Heritage Calgary has created a series of walking tours for those who wants to get out and explore their communities.

The tours are self-directed and can be explored from any point on the map.



#### **PLAQUE PROGRAM**

Since 1992, Heritage Calgary (formerly the CHA) and previous City heritage organizations have been placing plaques to recognize important heritage sites and allow Calgarians to learn about our heritage resources.

The plaque program is open to sites and properties that are listed on the Inventory of Evaluated Historic Resources. To date, Heritage Calgary's plaque program has recognized over 100 inventory sites.



## **CONSERVATION TOOLS & INCENTIVES**

#### PROPOSED INCENTIVES

- A two-year phased program to implement the heritage area policy tools
- Presentation of the proposed residential tax credit program to the Priorities and Finance Committee in 2022 for consideration in the 2023-2026 budget deliberations
- Heritage property owners would be eligible to a 75 per cent rebate on property taxes, up to \$50,000.

#### **EXISTING INCENTIVES**

The City of Calgary Historic Resource
 Conservation Grant: \$1.5 million per year, with
 \$500,000 reserved for residential properties
 and \$1 million for non-residential. Applicants
 to the grant are eligible to receive up to 15% of
 the assessed value of the property, up to 50%
 of the approved project cost.

# THREE-LAYERED PLANNING TOOLS

Layer 1: The Incentivization Tool

- Broadly incentivizes heritage conservation by offering additional development potential to developments that retain a heritage asset on site.
- Some proposed incentives include: removal of parking minimum standards; minor infill such as backyard suites; additional, contextappropriate live/work unit uses, such as gallery, café, instructional facility
- These incentives do not restrict or inhibit development
- Implemented through City-initiated amendment to Land Use Bylaw

Layer 2: Heritage Guideline Areas

- This layer works hand-in-hand with the Heritage Guideline Areas identified in Local Area Plans.
- Layer 2 builds on Layer 1 Incentive Areas.
   It makes all uses (other than those that are encouraged by the Layer 1 Incentivization tool) discretionary.
- Uses will also be subject to locally-specific heritage design guidelines. This will allow design guidelines to address heritage form elements.
- Implemented through Local Area planning process

Layer 3: Direct Control Heritage Areas

- This tool incentivizes heritage conservation in areas with the highest concentration of Heritage Assets.
- Allows for the creation of a Direct Control bylaw, which allows for even more specific architectural controls and limited redevelopment potential.
- Currently being piloted across 3 communities in Calgary (Mission-Cliff Bungalow, Crescent Heights, and Bankview)
- Implemented through the adoption of a Direct Control (DC) bylaw
